## How long do we store your personal data?

## Cookies, or similar techniques, that are used

Jansen Kunststoffen BV uses Google Analytics Cookies. We have entered into a processor agreement with Google for this purpose.

We have taken the following measures to ensure your privacy:

- the last octet of the IP address is masked
- all forms of data sharing with Google have been disabled
- we do not use other Google services in combination with the Google Analytics cookies

## Possibilities to view, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your possible consent to the data processing or to object to the processing of your personal data by Jansen Kunststoffen BV and you have the right to data portability.

This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
